As a volunteer with Saving Animals From Euthanasia, I agree to the following terms and conditions, being legally bound by them:

1. I will abide by the mission, rules, regulations, policies and programs of SAFE.
2. If I discontinue for any reason, or upon SAFE's request at any time, I will promptly return all of SAFE's supplies, equipment, records, money and other items in good clean condition.
3. I assume the risks of being bitten, scratched, injured, or frightened by cats, kittens, dogs and puppies in connection with my volunteer work with SAFE. SAFE is not liable for to me for any injuries, damages, liabilities, losses, judgments, costs or expenses whatsoever, which I might suffer or sustain in connection with the performance of my volunteer activities, unless they are the result of SAFE's gross negligence or intentional misconduct. I will indemnify, defend and hold SAFE harmless from and against any claims, lawsuits, injuries, damage, losses, costs or expenses whatsoever, sustained by any companion animal or any person in connection with my intentional misconduct or grossly negligent performance of volunteering for SAFE, or my breach of SAFE's rules, regulations, policies and programs.
4. I agree that if I become a Foster Home for SAFE, that I will keep any dog I am fostering on leash, or inside my home, or in my safely gated/locked yard at all times, and that I will keep the animal's collar on at all times. If I become a Foster Home for a SAFE cat, I agree to keep the animal(s) indoors at all times.
5. I understand and agree that I will be sheltering or providing foster care or boarding any of SAFE's animals in my home or business and I consent to SAFE visiting my home or business from time to time to observe the animals and their living quarters.
6. I agree to allow the removal from my home of any animal I am fostering at any time at the discretion of the Foster Home Coordinator for SAFE or of any Board member of SAFE, and understand that foster animals may be moved to another foster situation if deemed necessary at the time.
7. I have accurately and truthfully completed the SAFE Volunteer Application, and SAFE Agreement.
8. Any modification to this agreement must be in writing signed by both parties. This agreement is binding upon SAFE, me, and SAFE's and my respective heirs, successors, assigns, executors and personal representatives.

Please keep in mind that we are guests of the PETSMART store at our Saturday Adoption Center, and must conduct ourselves accordingly.
